I am pleased to advise that your application for the incorporation of the above association has been successful and attached is the association's Certificate of Incorporation.

The rules which were lodged with the application have now been registered and may only be amended by the passing of a special resolution at a general meeting of the members. A special resolution can only be passed at a general meeting with a 75 percent majority of members entitled to vote voting in favour. Written notice as provided in the association's rules must be given to the members. The amendment to the rules does not take effect until it has been registered by the Office of Fair Trading.

The incorporated association must comply with the provisions of the Associations Incorporation Act 1981 and the Associations Incorporation Regulation 1999. This includes the legal requirement that the management committee reviews the association's insurance requirements annually and reports the results at the annual general meeting. The management committee must also:

- advise the members of the risks should the management committee decide not to take out public liability insurance; and
- advise people applying to be members (before they become members) and nominees for election to the management committee whether the association has public liability insurance and the level of coverage; and
- advise any person or entity who the association may have dealings with if it does not have public liability insurance.
